WHAT YOU'LL LEARN

DAY 1

Instructional and participative exercises on day 1 define what data integrity is and help attendees identify areas throughout the lifecycle where data integrity is applicable and needs to be managed.

Additionally, attendees learn to identify and understand the drivers and potential root causes that can lead to data integrity issues, including causes related to culture of quality factors. By thinking through and discussing potential root causes, attendees will be able to determine patterns and themes that can help them and their organizations mitigate or prevent these issues in the future.

The learning on day 1 will also help attendees understand the likelihood and impact of data integrity on processes, product, patients and regulators. This session will reinforce and prioritize the patient focus and impact to ensure attendees have an emotional connection to the criticality and importance of this topic.



DAY 2

Instructional and participative exercises on day 2 assist attendees in understanding how to properly set up data governance and a surveillance process, and how to utilize risk assessment in evaluating both paper and electronic documentation processes.

Attendees will also gain information on the link between data integrity and the QMS and how to properly integrate these concepts with the objective of continuously managing data integrity and achieving sustainability in data validity and compliance.
